Extra Fees

The Bridal Suite located at our Ellisville location cost is \$175. This covers the entire room plus a personal assistant for the bridal party. Any extras like food & drink can be chosen from the food menu provided on request.

On location information:

For any additional stylist needed a \$100 fee will be applied (this is if more stylist/artists are needed, no matter how many more, not including one hair stylist and/or one makeup artist). Bride is responsible for all valet, parking, toll, and travel fees. Several St. Louis hotels do not charge us for valet and parking, but some do. There is a travel fee outside the Metropolitan St. Louis area to be discussed when location and mileage are disclosed.

3 person minimum for services, or \$250 is charged for the bride only.

All prices are subject to change before contract is signed and received.

Cancellation or Changes

It is your responsibility to pay the full amount agreed upon. Any wedding party/family cancellations that occur within 30 days of the wedding will result in a charge of \$100.00 per stylist/artist reserved and will be billed added to your total.

The total number of people receiving services is due no later than 4 weeks prior to the wedding date. If someone cancels you can fill that space with someone else. It is your responsibility to pay the full amount agreed upon.

You may add more IF THE TIME PERMITS at the pricing agreed upon. In case of an emergency and the stylist is not available the day of your wedding, we will send someone else in place or you will be fully refunded.

Time frames

We will provide the schedule on a spreadsheet for each wedding, that will have a final approval from the bride. Please have the first appointment ready 15 minutes prior to scheduled start time. All parties should have completely dry hair. NO specific time frames are guaranteed other than the first appointment. In the event that the group is delayed and/or scheduled time frames are not honored, an hourly rate of \$125 per hour will be applied for all time lost by the stylist as a result. Cancellations, late arrivals, and no shows will be charged 100%, and will be the financial responsibility of the individual authorizing this contract.

Extras

As the bride, I allow Mary Cates Salon and any/all its stylists to receive and use any photos from the photographer on the wedding day to be used on website and/or as marketing material.

Deposits and Payment

A non refundable deposit of \$175 is required to secure your wedding day, this payment will be applied towards your balance. 50% of total fees will be due 30 days before the wedding date. Cash, Check or Credit Card available for any deposits and final payment. Full Payment is due upon completion of work. If you would prefer to make a full payment before the wedding date, you may do so. wedding date, you may do so. If a check does not clear on the first attempt, the party authorizing this contract must make immediate arrangements to submit a cash payment in person. An additional fee of \$25 per day will apply until the payment has been received.

A Bridal practice is **not included** in the Wedding Day charges, the pricing for this is listed above under pricing.

If any changes are made as to the number of persons getting services, the person signing this contract will be responsible for paying for those services. You have 30 days before the wedding date to make any changes to the number of services.
